Project title: Enhance capacity of countries in Eastern Europe, the Caucasus and Central Asia in developing and implementing policies and strategies for sustainable housing and sustainable smart cities (Centre of Excellence on Sustainable Housing and Sustainable Smart Cities for the CIS countries)

Expected timing/ duration: January 2022 – August 2023

Objective and brief summary of the project:

The objective of the project is to enhance capacity of CIS countries in developing and implementing policies and strategies for sustainable housing and sustainable smart cities. The project will establish a Centre of Excellence for the CIS countries in Yerevan, Armenia; in cooperation with relevant national and local authorities; and will work to develop capacity building activities and relevant studies tailored to the needs of CIS countries. The project activities will be implemented in close collaboration with already established eight Geneva UN Charter Centres of Excellence, see information at https://unece.org/housing/charter-centres. The objective of the project will be achieved by implementing the following activities:

- A1.1. Provide regular coordination to support the establishment and operation of the new Centre of Excellence;
- A1.2. Provide communication support for the new Centre, including through social media, press releases and a brochure;
- A2.1. Organize six online workshops to raise the capacity representatives of national and local governments in the CIS countries;
- A2.2. Develop (in cooperation with other UNECE Centres of Excellences) an online training programme with a focus on the needs of CIS countries, (in English and Russian).

Expected results of the project:

- EA1. Enhance capacity of CIS countries to implement housing and urban development policies;
- EA2. Strengthen network of Geneva UN Charter Centres of Excellence to support CIS countries in the implementation of the Geneva UN Charter on Sustainable Housing.

Target group and beneficiaries of the project:

Beneficiary countries: Armenia, Azerbaijan, Belarus, Kazakhstan, Kyrgyzstan, Republic of Moldova, Tajikistan, Turkmenistan, Uzbekistan. The target audience is ministries and agencies in charge of housing, urban development, energy and land management; and national level institutions; representatives of local authorities, non-governmental organizations and agencies, including cooperatives and homeowner associations.

Justification of project and its relationship to the programme of work:

The proposed project directly contributes to the objective of the Subprogramme 8 "Housing and land management" "to strengthen member State -owned programmes and policies promoting decent, adequate, affordable, energy-efficient and healthy housing for all, smart sustainable cities, sustainable urban development and land management, and to advance evidence-based population and social cohesion policies" of the UNECE proposed programme budget for 2022. The project contributes to the Programme of Work of the Housing and Land Management Component of the Housing, Land Management and Population Subprogramme for 2022 (ECE/HBP/2021/9, para 14). A mandate for the establishment of the centres of excellence stems from the CUDHLM seventy-sixth session (report ECE/HBP/184) which included recommendations for the establishment of Geneva UN Charter Centres and the Guidance for the work of the centres (ECE/HBP/2016/2).
