We have the pleasure of informing you that the Norwegian Ministry of Environment has decided to allocate the equivalent of NOK 350.000 to the UNECE Trust Fund for Assistance to Countries in Transition and the UNOG General Trust Fund/ECE/the Århus Convention Local Technical Cooperation Trust Fund for 2003. E10

The contribution can only be used to support the participation of government representatives or NGO's from ODA-qualified NIS countries.


- Working Group on GMOs (Geneva and Sofia)
